LAUNCH OF LAW AWARENESS WEEKS @ CDC (LAWs @ CDC) 2019 AND “HELPING YOU HELP OTHERS” WEB-BASED SEMINAR SERIES

The Guest-of-Honour, Mr Edwin Tong, SC, Senior Minister of State, Ministry of Law and Health launched LAWs @ CDC 2019 and “Helping You Help Others” Web-Based Seminar (Webinar) Series on 4 September 2019 at Keat Hong Community Club.

2 Supported by five Community Development Councils (CDCs) and the Law Society Pro Bono Services (LSPBS), LAWs @ CDC 2019 introduced a new Webinar platform to (a) reach out to and engage the online community, (b) make it more accessible and convenient for anyone, anytime and anywhere to seek legal advice/knowledge; and (c) to build up a legal repository on useful topics.

3 More importantly, the objective of these webinars is to remove the stigma that comes with being seen when one physically attends such talks. With Webinars, residents can watch in the privacy of their own homes and take down notes at their own convenience. Webinars complement legal talks in helping to reach out and equip individuals with knowledge on legal issues as well as provide guidance on where they may seek social support to help their loved ones and themselves.

4 For the first time, the CDCs and LSPBS decided to take a more integrated approach towards helping residents with certain complex social needs. As such certain webinar topics will cover both legal advice from volunteer lawyers, social service from the Social Service Agencies (SSAs) and support from the CDCs. This is a reflection of the stronger partnership and collaboration between the community partners and the legal fraternity.

FREQUENTLY ASKED QUESTIONS

1. What is Law Awareness Weeks @ CDC?

The Law Awareness Weeks (LAWs) @ CDC is jointly organised by the five Community Development Councils (CDCs) and Law Society Pro Bono Services (LSPBS) to promote residents' awareness and instil a basic understanding of the law. In its fifth year of the collaboration, a series of **63** legal talks will be conducted from 4 September to 20 October 2019 across the five districts. The Talks will cover legal topics close to the hearts of the community.

Catered to the general public with no legal background, the talks aim to simplify “legal jargon” and are specially selected by each division based on the needs of their residents.

2. What do the CDCs and LSPBS hope to achieve through this collaboration?

Through the Law Awareness Weeks @ CDC 2019, the CDCs and LSPBS aims to:

- a. reach out to residents through law talks and equip them with the basic understanding of the law; and
- b. encourage lawyers/law students to volunteer within their home districts and expose them to community work.

3. How many lawyers and volunteers are involved in Law Awareness Weeks @ CDC 2019

30 lawyers are involved in the Law Awareness Weeks @ CDC 2019. Each talk comprises a 45-minute presentation followed by a 15 to 30-minute Q and A session.

4. What are the legal topics covered in Law Awareness Weeks @ CDC 2019?

The topics include Advance Legal Planning, Community and Neighbour Dispute, Consumer Protection, Employment Law, Family Law (Civil), Personal Debt Protection from Harassment and Syariah Law. For more details on the topics, visit <https://www.lawawarenessweeks2019.com/>

5. What is a Webinar?

A webinar is essentially a seminar or workshop held over the Internet, and it can be a presentation, discussion, demonstration, or other instructional session. Participants can log onto the webinar from their comforts of their own home and/or their personal electronic devices.

6. Why are the legal talks conducted through Webinar?

Webinars allow residents who may feel uncomfortable attending a taboo topic talk in person, to connect online with anonymity. This will allow them to gain legal knowledge at their own comfort and convenience.

7. What is the Webinar format and how do residents join a Webinar?

Volunteer Lawyers, Representatives from Social Service Agencies and a Moderator will host the Webinar.

Residents would require a web browser, internet connection, computer or mobile device. To connect to a legal talk via **GoToWebinar**, residents are to enter the webinar ID provided by the CDCs or the LSPBS and their email address.

8. What are the Webinar topics?

The four Webinar topics are (i) Divorce; (ii) Debt Management and Gambling; (iii) Good Samaritan Initiative; and (iv) Debt Management and Credit Card.

9. Who are the Community Partners involved in LAWs @ CDC 2019?

Apart from the CDCs, LSPBS, three Institutes of Higher Learning (National University of Singapore, Singapore University of Social Services, Singapore Management University), there will be new partners on board LAWs @ CDC 2019.
