COMMUNITY DEVELOPMENT COUNCILS HEAL FAMILIES AND RELATIONSHIPS AFFECTED BY THE PANDEMIC THROUGH PRO BONO LEGAL SERVICES

The Guest-of-Honour, Mr Edwin Tong, SC, Minister for Culture, Community and Youth & Second Minister for Law, together with the five Mayors will officially launch Law Awareness Weeks@CDC (LAW@CDC) 2021 webinars this year. The theme is **“Relationships and Healing”** in response to the fractured relationships caused by the current COVID-19 situation. They also welcomed a new partner, Community Mediation Centre (CMC) under the Ministry of Law, to anchor this area.

2 The LAW@CDC partners currently include five Community Development Councils (CDCs), Law Society Pro Bono Services (LSPBS), National University of Singapore (NUS), Singapore Management University (SMU), Singapore University of Social Science (SUSS) and Singapore Corporate Counsel Association (SCCA).

3 ***Minister Edwin Tong will deliver his keynote address*** virtually on Saturday 25 September 2021, 11am to the pro bono lawyers, law students, partners and guests. ***Together with Host Mayor Desmond Choo of North East District, and Chairman of LSPBS Mr Gregory Vijayendran SC***, they will touch on the role of mediation in the areas of Community, Family and Employment,

4 The COVID-19 pandemic has impacted lives for the past one and a half years. The five CDCs, together with its network of partners, recognise that Work-from-home and Home-based-learning arrangements have increased tensions among family members, resulting in a spike in family law cases. They believe that broken relationships may be resolved through community mediation and may therefore be a better way forward than costly litigation.

5 To reinforce the LAW@CDC 2021 theme, the CDCs together with LSPBS and CMC will promote community mediation as a means to attain healing, including to youths as the Youth Community and Legal Clinic

(YCLC) announced at LAW@CDC 2020 saw over 200 youth seeking legal advice between January to August 2021.

6 Following on from the launch of the YCLC, one of the webinars this year is “Help! I am a Victim of Online Harassment!” to provide support for such victims. The webinar will cover the legal remedies under the Protection from Harassment Act (POHA), and where victims of defamation, doxing, etc can seek legal assistance. Exceptional cases may also potentially come under LSPBS Ad Hoc Pro Bono Scheme for legal representation.

7 A total of 12 webinars will be streamed ‘live’ online over the six-week campaign period from 25 September 2021. Please visit <https://www.cdc.gov.sg/lawawarenessweeks> to find out more information and to register.

LAW@CDC is a nationwide effort to promote awareness and understanding of the law in the community through a series of legal talks for six weeks.
